Shipping Delays Due to Covid Impact Everyone



Delays in shipping attributed to complications in logistics because of Covid have put a strain on manufacturers, consumers, and business owners alike.

or almost two years, we have been battling with covid issues and its affect on business. While the personal losses are much greater, than anyone could ever express, the business issues and complications as a result of the virus impact everyone, as well.

Maintaining a normal, healthy society requires

a strong business community that supplies jobs, services, and products for our everyday life.

Businesses and manufacturers are now having to deal with another problem, which impacts not only their ability to provide jobs, services, and products, but has repercussions for the safety of both workers and consumers.

In the 1950's, container ships started to become

a source of shipping. Today, almost 90 percent of the world's trade is moved by water or airplane.

Presently, there is a historic volume of ships coming into the West Coast ports. The Northwest Seaport Alliance has reported a 14.1 percent increase in the number of ships compared to this time last year.

This same increase has been seen at all seaports up and down the entire west coast. Reportedly, there are approximately 56 container ships sitting at anchor or drifting off the coast of California, waiting to unload in Los Angeles and Long Beach. Ships are waiting days or even weeks to be unloaded with up to 18 newly arriving ships each day.

The Pacific Maritime Association has reported that equipment shortages, capacity limits, and logistical choke points are the major cause of the delay.

Imports have reportedly increased 26.5 percent, while exports have fallen 12.6 percent.

The Freightos Baltic Index reports container shipping costs have risen from \$3,224 in August of 2020, to over \$20,000. Air freight has increased 22 percent since the first of the year.

Overland trucking has been a big factor in delays

and accounts for the rising costs of products, as well. The increase in the cost of fuel and regulations associated with green energy have fragmented and handicapped the trucking industry and have forced several smaller operations to shut down due to affordability. This has created large gaps that other larger companies are attempting; yet failing to fill.

Shipping prices along with delays are creating shortages for essential parts and equipment.

It may be necessary to maintain extra parts or spare equipment for critical production lines, or locate alternate sources for supplying parts. Expedited delivery of parts or equipment cannot be depended upon.

New company requirements related to Covid may disqualify some vendors currently on approved vendor lists. It's advisable to review lists and determine if vendors need to be replaced or determine if the current ones are aware of any new procedures they must meet.

Routine maintenance of critical equipment is important to keep everything working properly. Safety appliances should be maintained and tested as recommended by the manufacturers. If testing is required by the regulatory authority, those

Risk of Carbon Monoxide poisoning leads to recall

Usines Giant Factories recall gas water heaters with Emerson Control Valves

Hazard: The heater's Emerson control valves can fail to close properly, causing soot to accumulate on the burner, posing a risk of carbon monoxide poisoning to consumers.å

Remedy: Consumers should immediately contact Usines Giant Factories, who will arrange to have the Emerson control valve replaced by a certified technician, and to receive a free replacement valve. Consumers who continue to use the water heaters while awaiting repair should have working carbon monoxide alarms outside of sleeping areas and on every level of the home.



Hazard: The smoke alarm and the combination smoke/carbon monoxide (CO) alarm can fail to alert consumers to a fire.

Remedy: Consumers should immediately contact Kidde for a free replacement alarm. Consumers should keep using the recalled alarms until they install replacement alarms.

Remedy: Consumers should immediately stop using the recalled spray guns and contact Hongkong Sun Rise Trading for a free replacement of the spray gun handle.

Remedy: Consumers should immediately stop using the recalled non-contact voltage testers and contact Klein Tools for instructions on receiving a free replacement tool.

THE PROGRAM

The National Association of Boiler Owners and Operators ("NABO") has established a Grant program to provide for and encourage eligible individuals to continue their education to pass the National Board Examination for boiler and pressure vessel inspectors and to become a National Board Commissioned Inspector.

This Grant program is administered by NABO. All awards are granted without regard to race, color, creed, religion, sexual orientation, gender, disability or national origin.

ELIGIBILITY

Applicants to the NABO Grant Program must be either:

- Children of individuals employed by or affiliated with ARISE Boiler Inspection and Insurance Company
 - Risk Retention Group policyholder companies ("ABIIC");
- Individuals who want to become commissioned boiler inspectors;
- Veterans of the United States Military Services; or
- Individuals with HVAC or Code or Non-Code boiler and pressure vessel manufacturing shop experience as a Welder or Quality Control.
- Must be a citizen of the United States.

ELIGIBLE EDUCATIONAL INSTITUTIONS

An Eligible Educational Institution is any accredited school that has a curriculum to prepare students to pass the National Board Examination to become a National Board Commissioned Inspector. See current National Board requirements here http://www.nationalboard.org/Index.aspx?pageID=390&ID=483

AWARDS

Applications will be reviewed against the program criteria by a selection process determined by NABO. Grant recipients will be selected on a competitive basis. If selected as a Grant Recipient, the student will receive an award in an amount of \$10,000 for tuition, books and related fees. Up to two awards will be granted each year. Applicants can reapply for additional awards each year while continuing their education.

Applicants are responsible for gathering and submitting all necessary information. Applications are evaluated on the information supplied; therefore, answer all questions as completely as possible. Incomplete applications will not be evaluated. All information received is considered confidential and is reviewed only by the NABO Grant Program Selection Committee.

SELECTION OF GRANT RECIPIENTS

Grant Recipients are selected on the basis of academic record, demonstrated leadership and participation in school and community activities, honors, work experience, statement of goals and aspirations, and a personal interview, if elected by the NABO Grant Program Selection Committee. Financial need is not considered.

Selection of Grant Recipients is made by the NABO Grant Program Selection Committee. All Applicants agree to accept the decision as final.

Grant Recipients will be notified as soon as possible after receipt of the completed application. Not all applicants to the program will be selected as Grant Recipients. Students may reapply to the program each year they meet eligibility requirements.

PAYMENT OF GRANTS

All awards will be paid directly to the Eligible Educational Institution. Grant Recipients will be responsible for all income taxes due on any awards.

OBLIGATIONS

Grant Recipients must keep at least a C average in all courses in order to keep the award. If the recipient's grades fall below a C average in his or her courses, the Grant Recipient shall be required to repay the award to NABO. Grant Recipients must submit a transcript of courses taken and grades received to the NABO Grant Program Selection Committee at the end of each grading period.

AMENDMENTS AND TERMINATION OF NABO GRANT PROGRAM

NABO reserves the right to review the conditions and procedures of the NABO Grant Program and to make any changes at any time, including termination of the NABO Grant Program.
